APPLICATIONS GUIDELINES

The course is offered as part of the 2016 Venice Summer Program, co-organized by the Wake Forest University School of Law (Director, Prof. Richard Schneider) and the University of Padua, Department of Public Law , International and EU Law - School of Law (Co - Director , Prof. Bernardo Cortese) .

Target audience : 20 students from the University of Padua and other Italian and European universities

The DiPIC will select up to 20 applicant students from the University of Padua and other Italian and European universities

Among them

- **15 students of law and humanities enrolled at the University of Padua** (incoming exchange students are included)
- **5 students enrolled at other Italian and EU Member States Universities, at EU Associated States Universities, and at non-European Universities having a partnership agreement with UNIPD**

Students enrolled at other Italian and EU Member States Universities, at EU Associated States Universities, and at non-European Universities having a partnership agreement with UNIPD :

DiPIC will consider applications by students of Law and Humanities Schools, enrolled at Italian or other EU Universities, at EU Associated Countries' Universities, or at non-European Universities having a partnership agreement with UNIPD (refer to <http://www.unipd.it/en/erasmus-and-other-exchange-programmes>)

[Students means: a) students of first, second or third cycle of qualification according to the framework of qualifications for the European Higher Education Area, or b) students of single cycle 4/5 years diplomas in Law]

Essential language requirement

An adequate knowledge of active and passive English language, at least equivalent to a B2 CEFR level is an essential requirement for admission to the course

Candidates must submit any certificates of attesting their language proficiency. In absence thereof, an interview is required, which can take place via Skype. Applicants must therefore indicate their Skype and e-mail accounts. Applicants accept to receive a Skype appointment notice via email at least 24 hours in advance.

Selection criteria

Selection will be carried out according to the following criteria:

Incoming Exchange Students, Students enrolled at other Italian and EU Member States Universities, at EU Associated States Universities, and at non-European Universities having a partnership agreement with UNIPD, as well as UNIPD students not enrolled at the Law School or at a PhD School in legal matters will be admitted on the basis of their attitude to successfully attend Law, Literature and Culture classes, according to their academic CV and motivation letter

Tuition and extramural activities fees

UNIPD students, including incoming exchange student, please refer to the Italian version of the guidelines

All other applicants are required to pay a **tuition and extramural activities fee of € 400**

How are classes organized?

Attendance is mandatory. Active participation is required.

How are exams organized?

Students will be evaluated on the following basis

- i) students will issue a 3-4 page reflection by the end of the course, to relate one or more of Biennale exhibits to themes of the class (establishing or violating law; justice; supporting or undermining the status quo, exclusion/inclusion, etc.). ;
- ii) students will produce a 15- to 20-page paper they will turn to Prof. Schneider during the month of August or September; The topic of this longer paper will be based on the readings and films but you must clear it with Prof. Schneider before you begin to write
- iii) students' attendance and participation in class discussions and completion of the out-of-class exercises and field trips will also be assessed

ECTS Credits Awarding

Successful UNIPD School of Law students will be granted 6 CFU / ECTS credits.

Incoming exchange students will have to modify their LA accordingly.

Other Universities' students will be issued a transcript of records. Home University recognition conditions will then apply.
